THE DEAN BURGON SOCIETY, INC. proudly takes its name in honor of Rev. John William Burgon (1813–1888), the Dean of Chichester in England, whose tireless and accurate scholarship and contribution in the area of New Testament Textual Criticism; whose defense of the Traditional Greek New Testament Text against its many enemies; and whose firm belief in the verbal inspiration and inerrancy of the Bible, we believe, have all been unsurpassed either before or since his time!

Author To Speak

One of the speakers we have arranged to speak to us is Rev. Jack Moorman, author of five detailed studies defending the King James Bible and its underlying Masoretic Hebrew text and Textus Receptus Greek text. He is a member of our DBS Executive Committee. I had the pleasure of meeting Brother Moorman for the first time a few months ago when he stayed with us overnight. After conversing with him for several hours, we decided to make a tape recording of our interview. New Book

In our interview, I asked Brother Moorman if he were working on

any new books at the present while in this country. He said he wasn't, but I mentioned to him that Dr. Sightler would like to print up his FOREVER SETTLED book in regular book format so he could continue to use it as a textbook. Brother Moorman said he would like this very much. He also said he would like to combine some of the essential portions of his other four books into this one volume to make it even more useful to the students. He has been in touch with Dr. Sightler, and these are the Rev. Moorman hopes he can complete this work before returning to the mission field in England. Please pray for this important project. We are overjoyed about this development!

Greenville Radio

The DBS is sponsoring a 30-minute program each week over radio station WTBI, in Pickens, SC, which is close to Greenville, SC. The station is operated out of the TAB-ERNACLE BAPTIST CHURCH where Dr. Harold Sightler is pastor, and where Dr. James Sightler teaches this class. The broadcast is "IN TRADITIONAL BIBLE DEFENSE OF TEXTS" and endeavors to awaken the listeners to the beauties, accuracy, and dependability of our KING JAMES BIBLE. AV-1611 In Print

Nelson publishers have finally brought the <u>AUTHORISED VERSION--</u>
1611 BIBLE back in print. We have been trying to urge them to bring this back when it went out of print several years ago, and at last this has come to pass! If you want a

copy, you may get it by writing to the DBS for it. It is #1102 and is yours for a GIFT to DBS of \$32.00. It is a page by page reprint of the original 1611 edition of the KING JAMES BIBLE, including the footnotes, and marginal notes on a page by page basis. I have examined this book and compared it with my copy of the original AUTH-ORISED VERSION--1611 obtained from the Library of Congress a few years ago. The only difference between the original 1611 and Nelson's reprint of it is the style of the type. The original is in what we call German script (very difficult to read until you learn the different shapes of some of the letters). Nelson's reprint is in our regular Roman script that we use today.

Spanish Bible

We are pleased to announce that the newly formed GLOBAL BIBLE SOCI-ETY with headquarters in Asheville. North Carolina. is taking on the project of REVISING THE SPANISH BIBLE. The goal is to bring it in line with the Masoretic Hebrew Text of the Old Testament and the Received Greek Text of the New Testament. This would make it a trustworthy Spanish equivalent of the English King James Bible. The revision will be done as publicly as possible. The coordination of the project will be handled by Pastor J. Paul Reno, 1625 Woodcrest Road, Hagerstown, MD 21740. Please send any input or information to him.

Spanish Changes

As many of our readers no doubt know already, the Spanish Bible has its problems when it comes to being conformed to the original language texts in every particular. In the New Testament especially does it Yet that revision need REVISION. should not be in the direction of erroneous Westcott and Hort Greek text as exhibited by the Nestle-Aland 26th Edition Greek New Testament. Nor should it be in the direction of the erroneous socalled 'Majority Greek Text' as exhibited in Nelson's 1982 or 1985 editions of that text. Rather, it is to be conformed to the Textus Receptus that underlies the King James Bible. This is exactly what the <u>GLOBAL BIBLE SOCIETY</u> is attempting to do. As one who speaks Spanish, I long to see this accomplished.

Help Pastor Reno

I hope all our readers will help Pastor Reno in this endeavor. He is a trustworthy, diligent, thorough, faithful man of God. I have known him ever since I taught with his father, Rev. John Reno, at Cedarville College during 1953-54. His dad was a man of God who had some starch, some courage, and some boldness to speak his mind in the things of God. His son, J. Paul, was just a young man at the time. but has now grown up in his father's footsteps to do the work of God. We are happy to have him as a member of our DEAN BURGON SOCIETY Executive Committee.

Maj. Text Society

In addition to the various differences in methodology and conclusions between the DEAN BURGON SOCIETY and the newly formed MAJORITY TEXT SOCIETY (MTS), our readers should note the VAST difference in theology and doctrine. Quoting from the MTS documents, we read:

"Is the Majority Text Society only for Greek Scholars?
No. Our members represent a spectrum of countries, nationalities, THEOLOGICAL CONVICTIONS, educational backgrounds, and skills in the New Testament . . . "

Note further, in the next paragraph:

"How Can I Join The Majority
Text Society? . . . IHERE
ARE NO DOCTRINAL OR MEMBER—
SHIP REQUIRMENTS other
than your signed statement
that you agree with the Majority Text position, or
that you are open to testing
it as a viable option. . .
"

Judging from their own statements.

therefore, the MTS represents a "SPECTRUM OF . THEOLOGICAL CONVICTIONS. Furthermore, THERE ARE NO DOCTRINAL . . . RE-QUIREMENTS. What does this mean? To me it means that there can be rank apostates and other unbelievers in the MTS, side by side with those who believe the Bible. Their members need share no common doctrine at all, since this is not a requirement for membership. seems extremely odd that a society whose stated purpose is to restore the New Testament Greek Text to that of the autographs (if possible) could have within its membership (if not one day even dominate or control) those who don't even believe the **DOCTRINE** of Biblical inerrancy, infallibility, and plenary, verbal inspiration! Members may be fundamentalists or neo-evangelicals, or liberal apostates. They may belong to the National and/or World Councils of Churches, the National Association of Evangelicals, or not. Where is the safeguard here? Where is the protection of **DOCTRINAL PURITY**? is built on an inclusive, ecumenical house of sand!

DBS & Doctrine

By way of contrast, the DEAN BURGON SOCIETY (DBS) has a very STRICT requirement for membership comes to "DOCTRINAL" when it. and/or "THEOLOGICAL VIEW-POINTS." (5) the Death of Christ; (6) the Resurrection of Christ; (7) Salvation; (8) Heaven and Hell; (9) Spiritual Unity; (10) the Purity of the Church; (11) Separation; and (12) Creation. We fly our colors high, and have a STANDARD to which only those of STRONG "THEOLOGICAL VIEW-"DOCTRINAL" con-POINTS" and victions can find fellowship. are proud of our convictions, and will not yield to an all-inclusive, ecumenical common denominator of nothingness!

DBS Distinctives

We are a ONE ISSUE SOCIETY.

Other than our "DEFENSE OF TRADI
TIONAL BIBLE TEXTS," here are a

few of our DBS DISTINCTIVES:

(1) "SEPARATION. We believe in obedience to the Biblical commands to separate ourselves unto God and from worldliness, ecclesiastical apostasy, and 'disorderly' brethren. (2 Corinthians 6:14--7:1; 1 Thessalonians 1:9-10; 2 Thessalonians 3:6, 13, 14-15; 1 Timothy 6:3-5; Romans 16:17; 2 John 2:9-11).

Here is both PRIMARY as well as SEC-ONDARY separation.

(2) "CREATION. We believe in the Biblical account of the creation of the entire universe, angels, and man; that this account is neither

allegory nor myth, but a literal, historical account of the direct, immediate creative acts of God IN SIX LITERAL SOLAR DAYS without any evolutionary process, either naturalistic or theistic; . . ."

No evolution here; and no day-age theory either! We hold to "SIX LITERAL SOLAR DAYS" of creation.

(3) TONGUES. "We believe that the so-called 'sign qifts' (1 Corinthians 12:7-11) of the Holy Spirit (such as TONGUES, prophecy, know-CEASED WITH etc.) THE COMPLETION OF THE NEW TESTAMENT CANON around 90 or 100 A.D. AND ARE NOT PRE-(1 Corinthians SENT TODAY. 13:8-12; Hebrews 1:2; 2:3-

New Group Forms

It is seldom that new groups of fundamentalist, separatist persuasion (such as the DEAN BURGON SOCIETY is) make their way onto the stage of history. Such was the case, however, with a new Baptist group known as the INDEPENDENT BAP-TIST FELLOWSHIP. It was formed on Wednesday, October 3, 1990, in Oshkosh, Wisconsin. Of particular interest to our DEAN BURGON SOCIETY is this new group's doctrinal position

on subjects of the Bible. In their "STATEMENT ON THE KING JAMES VER-SION," the I.B.F. stated:

JAMES VERSION IN OUR CONFERENCE PREACHING; and we trust our speakers will honor this preference. As our Baptist forefathers, we continue to believe that the KING JAMES VERSION is the Word of God in English."

This is a refreshing statement! In their "STATEMENT ON BIBLE PRESERVA-TION," the I.B.F. stated:

> "We believe God has promised in both the Old and New Testaments to preserve His Words as given to us in the original Hebrew/Aramaic and Greek texts . . . By His Providential care, we believe God has kept His Word pure down thru the ages as He promised, and we reaffirm our belief in what our Baptist forefathers wrote in their London Baptist Confession of 1677 and 1689. It states in part: 'The Old Testament in Hebrerw . . . and the New Testament in Greek . . . being IMMEDIATELY INSPIRED BY AND BY HIS SINGULAR PROVIDENCE KEPT CARE AND PURE IN ALL AGES, are therefore AUTHENTICAL."

We are glad to see the I.B.F. take as good a stand as they did!
