Apology to Editor

Since the following concerns DBS President, Dr. D. A. Waite, this APOL-
 OGY is included here.

Press Statement by Word, Inc., Colson & Vaughn

"In September, 1992, Word, Inc. published the book *The Body* by Charles Colson and Ellen Santilli Vaughn. The first edition of the book contained statements concerning events which had allegedly occurred while the Rev. Dr. D.A. Waite was the pastor of Immanuel Baptist Church in Newton, Massachusetts in the early 1960's. After initial contacts between the parties, the Rev. Dr. D.A. Waite, a Baptist minister in Collingswood, New Jersey and the Director of THE BIBLE FOR TODAY, INC., a nonprofit Baptist organization, instituted a libel action against the publisher and authors of *The Body* in federal court in New Jersey.

While *The Body* correctly noted that there had been dissension within Immanuel Baptist Church, to the extent that *The Body* portrays Dr. Waite as engaged in "blackmailing" his parishioners or engaged in a fistfight in the Immanuel Baptist Church with members of the congregation, the publisher and the authors of *The Body* have now discovered that these events as portrayed in *The Body* are not accurate. Unfortunately, the authors relied on interview accounts concerning events which occurred thirty years earlier, and had been informed and mistakenly believed that Dr. Waite was deceased when the book was written and published, and therefore did not contact him before publication. Had the authors been able to talk with Dr. Waite, and review his tape-recorded sermon from Immanuel Baptist Church, they would have written the chapter differently.

The authors and publisher of *The Body* regret that the publication of these statements in *The Body* caused pain and em-

barrassment to Dr. Waite, and have expressed their sincere apologies to Dr. Waite and his family in the spirit of Christian reconciliation.

The authors and publisher of *The Body* have amicably resolved this dispute with Dr. Waite. While the parties regret the conflict, they affirm the importance of pursuing reconciliation according to biblical mandate.
